NEET 2024: Delhi HC issues notices to NTA, seeks response on pleas of aspirants



Court on Wednesday issued notice to National Testing Agency (NTA) in a batch of petitions filed by NEET aspirants. Aspirants have raised the issue of leakage of question paper, awarding compensatory marks and anomaly in question of NEET 2024. A large number of petitions are pending before different High Courts.

Justice Neena Bansal Krishna has issued notice to NTA and listed the matter on July 5. Advocate Gauhar Mirza and Suriti Chaudhary submitted before the court that there are absolute irregularities.

NEW DELHI: After the formation of the Modi government for the third consecutive time at the Centre, Prime Minister Narendra Modi will visit his parliamentary constituency of Varanasi for the first time on June 18. He will reach Lal Bahadur Shastri International Airport Babatpur at around 4:30 pm. From there he will go straight to the venue. The PM will be given a grand welcome at various places throughout the way. Prime Minister Modi will honour farmers from Varanasi and release the 17th instalment of the Samman Nidhi, benefiting about 267,665 farmers in Kashi. This visit is dedicated to the farmers Following the Kisan Sammelan, he will visit the Baba Kashi Vishwanath Temple and participate in the world-famous Ganga Aarti at Dashashwamedh Ghat. BJP Kashi Zone President Dilip Patel said, "It is a matter of pride for all of us that Prime Minister Narendra Modi took oath as MP from Varanasi for the third time and as Prime Minister of the country for the third time. After being elected as the Prime Minister of the country and MP from Varanasi for the third time, he is coming to Varanasi on 18 June". Swati Maliwal assault case: Bibhav Kumar moves Delhi HC for regular bail

NEW DELHI : Bibhav Kumar, former aide of Delhi Chief Minister Arvind Kejriwal, moved the Delhi High Court on Wednesday seeking regular bail in the Swati Maliwal alleged assault case. The matter is likely to be listed on

Recently, Delhi's Tis Hazari Court dismissed the regular bail plea of Bibhav Kumar. The court dismissed the bail application in view of threats received by the victim, Swati Maliwal and apprehension of influencing the witnesses by the accused.

While dismissing the bail application, the court observed, "In view of the fact that investigation is at an initial stage and there is a fear in the mind of the victim regarding her security as well as the security of her family members.... There is also apprehension that the accused Bibhav Kumar would influence the witnesses, if at liberty.

"So I do not find any merit in the bail application of accused Bibhav Kumar. Hence, the present regular bail application of accused
