

Over 1.76 crore school students from all states, UTs participate in Project Veer Gatha 4.0

NEW DELHI : More than 1.76 crore school students from all 36 States and UTs participated enthusiastically in Project Veer Gatha 4.0 on Wednesday in the national capital, a press release said.

The students have sent poems, paintings, essays, videos, etc. in honour of the acts of bravery and sacrifice of the officers/personnel of the Armed Forces.

Project Veer Gatha was instituted in 2021 with the aim of disseminating the inspiring tales of valour, selfless sacrifice and courage of the Gallantry Awardees and the life stories of these bravehearts among the students to inculcate the spirit of patriotism amongst them.

Education Ministry in a statement said that Project Veer Gatha enhanced this noble aim by providing a



platform for the school students to do creative projects/activities based on heroic deeds and sacrifice of gallantry award winners.

Three editions of the Veer Gatha Project have been conducted in 2021, 2022 and 2023, respectively. Under the Veer Gatha Project 4.0, the following activities have been conducted to date:

As per the Education Ministry, "Schools have conducted various projects/activities

(from September 16 to October 31) and have uploaded a total of 4 best entries from each school, on the MyGov portal."

"Simultaneously, to enrich the knowledge about the gallant heroes and unsung stories among school students, the Ministry of Defence, through its field organisations or Army/Navy/Air Force, has organized virtual meets/face-to-face awareness programmes/sessions for schools across the country," the Ministry added.

Since its inception, the project has witnessed increasing participation of students across the country. It may be noted that 8 lakh students had participated in the Veer Gatha Project (Edition-I); 19.5 lakh students participated in the second edition and the third edition

saw a participation of 1.36 crore students.

According to the release, during the Veer Gatha Project Editions I and II, 25 winners (Super 25) were selected and their felicitation was done by the Ministry of Education and Ministry of Defence in New Delhi. In Veer Gatha Project 3.0, 100 winners (Super 100) were selected at the National Level. This year too, under Project Veer Gatha 4.0, 100 winners will be selected and their felicitation will be done jointly by the Education and Defence Ministry.

Each winner will be awarded a cash prize of Rs 10,000. Also, there will be 4 winners each at the District level and 8 winners each at the State/UT level and all such winners will be felicitated by the respective District & State/UT, it added.

Andhra Pradesh: Chandrababu Naidu highlights TDP's welfare policies in assembly

AMARAVATI : Stressing that welfare, development, and good governance are the policies of the TDP-led National Democratic Alliance (NDA) government in Andhra Pradesh, Chief Minister Chandrababu Naidu on Wednesday told the Assembly that the State Government would function with the sole aim of improving the living standards of the people.

"The state government is moving ahead by implementing the Super-Six schemes as promised in the election manifesto," Naidu said, adding that it was the TDP that had laid the foundation for welfare, as the party founder, the late NT Rama Rao's slogan was everyone should have food to fill the stomach, clothes, and the necessary shelter, according to an official release. "The Rs 2 kg rice scheme, which was introduced by NTR, is now being implemented across the country, and he also built houses for the poor with the aim of shifting them from the huts that they were living in then to pucca houses," Naidu recalled.

Addressing the Assembly on the completion of 162 days of the TDP-led NDA Government, Chandrababu said that Andhra Pradesh has a long history. Though elections and people's verdicts are nothing new, the awareness that the people have exhibited in the recent polls is really a history that he termed as a revolution. "In fact, these recent elections reminded everyone of the tsunami that struck the State when the TDP was founded by NTR," he further said.

Centre Notifies appointment of Justice D Krishnakumar, as Chief Justice of Manipur High Court

NEW DELHI : The Central Government, through the Ministry of Law and Justice, on Wednesday notified the appointment of Justice D Krishnakumar as Chief Justice of the High Court of Madras High Court as Chief Justice of the High Court of Manipur.

Notification issued stated that "In exercise of the power conferred by the Constitution of India, the President is

pleased to appoint Justice D Krishnakumar, Judge, Madras High Court as Chief Justice of the High Court of Manipur with effect from the date he assumes charge of the office, consequent upon the superannuation of Justice Siddharth Mridul, present Chief Justice of the High Court of Manipur on 21.11.2024."

On November 18, 2024, the Supreme Court Collegium, consisting of the newly appointed Chief Justice of India, Justice Sanjiv Khanna, along with Justice BR Gavai and Justice Surya Kant, recommended the appointment of Justice D Krishnakumar as the next Chief Justice of the Manipur High Court. Before his elevation to the bench, Justice Krishnakumar gained extensive experience as an advocate, specializing in civil, constitutional, and service matters, particularly in constitutional law, at the High Court. The Collegium noted his strong legal acumen, competence, and high level of integrity and honesty. In recommending Justice Krishnakumar, the Collegium also considered that, currently, there is only one Chief Justice from the Madras High Court among the Chief Justices of the High Courts.

NEW DELHI : The winter session of Parliament will commence on November 25 and subject to exigencies of Government Business, the session may conclude on December 20. There will be no sitting of Lok Sabha and Rajya Sabha on December 26 to commemorate the "Constitution Day", the Ministry of Parliamentary Affairs said in a release.

Notably, Union Minister of Parliamentary Affairs, Kiren

Rajiju will hold a meeting with the floor leaders of political parties in both houses of the Parliament, ahead of the Winter Session of Parliament.

The all-party meeting will be held at 11 AM on November 24, at the Main Committee Room, Parliament House Annexe, New Delhi. The meeting will be presided over by Defence Minister Rajnath Singh.

During the winter session, the government is expected

to make an effort to pass the Waqf Amendment Bill which is currently with the Joint Parliamentary Committee of the house. During the session, the government could also look to introduce the 'One Nation One Election' bill.

The Joint Parliamentary Committee on Waqf Amendment Bills 2024 is holding its meetings regularly in different states with different stakeholders, to solve

their queries and find a common consensus on the contentious bill.

Recently, Prime Minister Narendra Modi highlighted that his government was working towards achieving 'One Nation One Election' which will ensure simultaneous polls for Lok Sabha and state assemblies.

"We are now working towards One Nation One Election, which will strengthen India's democracy, give optimum outcome of India's resources and the country will gain new momentum in achieving the dream of a developed India. Today, India is moving towards One Nation One Civil Code that is a Secular Civil Code," he said.
